Scanned Copy <b>Philippine Passport</b> with at least 6 months validity + Old Passport if with stamps	
Scanned Copy of the <b>Passport's Bio Page</b> (Page 2 & 3) (make sure Page 3 is signed)	
Scanned Copy of <b>previous and valid advanced visa</b> for frequent travelers. (USA, CANADA, UK, SCHENGEN, JAPAN, AUSTRALIA, NEW ZEALAND, KOREA)	
<b>Accomplished and Questionnaire</b> (document file to be provided)	
Scanned Copy of the <b>Original PSA Birth and Marriage</b> (if applicable) <b>Certificate</b> should be no more than 1 year old. NOTE: * If “LATE REGISTRATION”, submit <b>Baptismal Certificate and School Record (Form 137)</b> * If no record of Marriage in PSA, submit <b>CENOMAR</b>	
<b>Cover Letter</b> (explaining why you want to visit Australia) NOTE: It isn’t required but it would help a lot on the chances of approval of your application.	
FINANCIAL REQUIREMENTS	
Scanned Copy of the <b>Original Bank Certificate</b> (Ideal amount for the current balance is P100,000) Including type of account, opening date, average daily balance and current balance	
Scanned Copy of the <b>Original Bank Statement</b> (last 3 months) (Ideal amount for the Average Daily Balance is P50,000)	
<b>ITR (Income Tax Return) Form 2316</b> for individual / <b>Form 1701 or Form 1702</b> to for companies NOTE: It must have amount of gross income and a stamp of recipient, if tax is not withheld	
You may provide all <b>Proof of Assets</b> like <b>Investments, Land Titles, Pension Pay, Credit Card Statement, Pay slips</b> , etc. (if available)

STEPS IN VISA PROCESSING
<p><b>FOR B2B APPLICANTS:</b></p> <ol style="list-style-type: none"> <li>1. Email Scanned Copy of all the requirements to <a href="mailto:visa@pinoyonlinebiz.com">visa@pinoyonlinebiz.com</a>. (Your agency email must be the one to be used in submitting all the requirements to us, not your customer's email).</li> <li>2. Once all the documents have been assessed and it is okay to be submitted, you may pay the visa assistance fee. Make sure everything is complete because the embassy will not accept incomplete documents. (In case we found the documents insufficient, we will charge P300/applicant as new assessment fee.)</li> <li>3. Forward the payment slip to our email for verification.</li> <li>4. We will forward the application to Australia Embassy after we received all the documents; processing time is up to 3040 working days.</li> <li>5. A decision will be notified to you once available.</li> </ol> <p><b>IMPORTANT NOTE:</b> Do not disclose to your customer any details of the transaction of your agency to us, as you are carrying your own brand and we do not want your clients to go directly to us. No agency dropping. Once your customer has transacted directly on us, it will be considered as our direct client and no commission shall be given to your agency.</p>
IMPORTANT REMINDERS:
<p><b>Visa approval</b> is at the discretion of the Visa officers. <b>We cannot guarantee 100% approval.</b></p>
<p><b>Visa submission is within 3 working days</b> after the receipt of complete documents and if there are no additional requirements needed. We strongly suggest applying at least 1 month prior to travel date because there are times where the visa officer is <b>requesting for additional documents</b>.</p>
<p><b>All submitted documents</b> are <b>considered as FILED</b> and <b>no refunds</b> shall be made in case you may have a change of mind on your application.</p>
<p>For <b>denied application</b>, you can <b>re-apply after 6 months</b>. <b>No Refunds</b> shall be made for the Visa Assistance fee regardless of the decision made on your application.</p>
